#### **Overview**

An external auditor is essentially a 'specialised' type of accountant who verifies the accounting records and financial reports of an organisation, which are prepared and issued to its stakeholders. Whereas, the accounting records and financial reports are usually prepared by finance personnel, such as your typical accountants and bookkeepers.

An external auditor's role is not only vital to providing an organisation with credibility in its financial reporting, it is critical to creating confidence within the market, which also has a direct impact on decision making, including consumer behaviour.

To do this, an external auditor must first have a sound understanding of the accounting principles applied by an organisation, as well as the detailed processes used by finance personnel as part of the overall financial reporting process. This is why the pathway to becoming an external auditor *starts* with completing a **Bachelor Degree in Accountancy** (or the like) and requires the completion of post graduate studies such as a Diploma with Chartered Accountants Australia and New Zealand (CA) or Certified Practising Accountants (CPA).
